Registration

Registration for the ITPD is to be made electronically by using the respective registration tool provided on the ITPD homepage (www.itpd-tickborne.com).

A letter of confirmation, payment receipt or invoice if required will be sent by e-mail after a fully completed registration form.

Registration Fees for different categories of the congress are shown on the registration page www.itpd-tickborne.com.

Registration Fee for Participants includes:

- Admission to all scientific sessions
- Entrance to poster & exhibition area
- Lunches and coffee breaks
- Name badge and all printed materials
- Congress bag

Travel and accommodation costs are not covered by the registration fee.

By registering to the ITPD 2019 participants agree that neither the organising committee nor the congress office assume any liability whatsoever. Participants are requested to make their own arrangements for health and travel insurance. The conference fee does not include insurance.

Methods of Payment

Payments can be made either by bank transfer or via credit card. The request for payment of the registration fee is effected in the name and on the account of the Austrian Society for Hygiene, Microbiology and Preventive Medicine (ZVR Nr./number in central register of associations: 720944593). The registration fee does not include VAT and therefore does not entitle to deduction of input tax.

Payment via Bank Transfer

All fees shall be paid in EUR (€), free of all bank charges within 14 days of submission. Participant's last name and congress name (ITPD19) must be indicated on the transaction receipt of the bank transfer. Any bank charges incurred are to be paid by the participant.

Payment via Credit Card

Confirmation of your credit card payment, along with the registration confirmation, will be made available immediately after payment.

Cancellation of Registrations and Refunds

Notice of cancellation (e.g. in case of sickness or any other personal reasons) must be made in writing by e-mail to azmedinfo@media.co.at.

Letter of invitation

To receive a letter of invitation, participants must be fully registered to the congress and payment in full has to be submitted. The attention of the participants is drawn to the fact that the letter of invitation has to be requested sufficiently in advance. The letter of invitation does not financially obligate the ÖGHMP in any way. All expenses incurred in relation to the ITPD 2019 congress are the sole responsibility of the participant. Any costs for express mailing of documents must be covered by the participant.

Limitation of Liability
