## **Methods of Payment**

Payments can be made either by bank transfer or via credit card. The registration fee does not include VAT and therefore does not entitle to deduction of input tax.

### **Payment via Bank Transfer**

All fees shall be paid in EUR (€), free of all bank charges within 14 days of submission. Participant's last name and congress name (HRWM19) must be indicated on the transaction receipt of the bank transfer. Any bank charges incurred are to be paid by the participant.

### **Payment via Credit Card**

Confirmation of your credit card payment, along with the registration confirmation, will be made available immediately after payment.

## **Cancellation of Registrations and Refunds**
